Due to the obsolescence of the phono plug (part number 406213) used on the end of the VSM 6000 Nurse Call Cable Part number 6000-NC, A new version of this part is being released to support the Vital Signs Monitors (CSM, CVSM, and CIWS). This change has no impact to design functionality. The product IFU's and the instruction card part number 713970 supplied in the box for 6000-NC will be updated.

Current CSM IFU Content:

To connect the monitor to a Nurse Call system, you must have a cable that has been adapted to your Nurse Call system (REF 6000-NC), rated 25V AC or 60V DC maximum at 1A maximum.

Current CVSM/CIWS IFU Content:

To connect the monitor to a Nurse Call system, you must have a cable that has been adapted to your Nurse Call system (REF 6000-NC), rated 50V DC maximum at 500mA (DC or ACRMS).




