Dear Valued Customer,

This letter is to inform you that Baxter will discontinue all service, repair, technical support and replacement parts relating to the <u>Lamarr wireless radio card</u> in **Welch Allyn Connex** Vital Signs Monitor (CVSM) and **Welch Allyn Connex** Integrated Wall System (CIWS) devices, effective immediately. Affected CVSM/CIWS wireless devices include those manufactured June 2018 or earlier. For instructions on how to determine device manufacturing date using the serial number, refer to Appendix A.

This does not impact CVSM 6400/6700 or CIWS 8400 series devices. To determine which radio card (if any) is currently installed in your CVSM/CIWS device, refer to Appendix B.

Please be advised that by continuing to use this product beyond the specified End of Service and Support date, you are fully assuming the cybersecurity risk of using the product. Any and all risk, including but not limited to your networks, data privacy, and/or patient safety, arising from a cybersecurity incident associated with the product will be transferred to your organization on this date.

If you have a device with a Lamarr radio and are interested in an upgrade, please contact our technical support department or your local sales representative.

APPENDIX B

To determine which radio card (if any) is installed on your CVSM/CIWS device:

- a. Touch the **Settings** tab.
- b. Touch the Advanced tab.
- c. Touch Enter Password.
- d. Enter your password and touch **OK**.The General tab appears.
- e. Touch the Service tab.
- f. Touch the **Device** tab
- g. Locate the radio information under Device Name.
 - i. A "Radio-Lamarr" listing indicates an installed Lamarr radio card in the device; a "Radio-Newmar" listing indicates an installed Newmar radio card.

CVSM/CIWS devices with no radio card or with a Newmar radio are not impacted by this letter.
